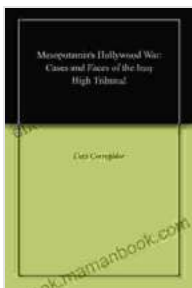

### **Key Cases and Accused Individuals**

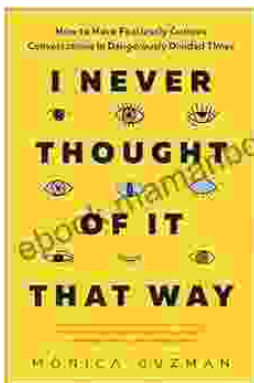
